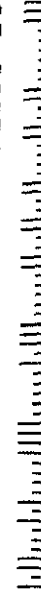

On November 24, 2009, the Staff of the Missouri Public Service Commission filed a complaint against the above-named Respondents. The company alleges that Respondents are providing sewer service without Commission authority. After discussions with some of the Respondents Staff informs the Commission that Kandis Davis, through her attorney, has expressed a commitment to apply for a Certificate of Convenience and Necessity. To allow time for an application to be filed, Staff requests that the Commission toll, until January 31, 2010, the time limitation for answers to be filed.

The Commission has reviewed Staff's motion and finding it reasonable will grant the requested relief.

1. The Staff of the Commission's motion that the Commission toll the time for answers to be filed is granted.
2. The time by which answer are to be filed is tolled until January 31, 2010.

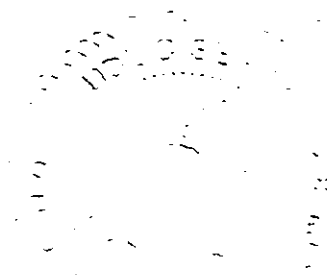
