ORDER REVOKING AUTHORITY

On May 4, 2017, the Commission's Staff filed a Motion to Revoke Authority. In that motion, Staff states that it wants the Commission to revoke the authority of Coast International, Inc. ("Coast") to resell telecommunications services because Coast has failed to file a statement of revenue, assessment payment, and annual report for 2015. The Commission sent notice to Coast, and ordered Coast to respond no later than June 4, 2017. Coast failed to respond.

Commission Rule 4 CSR 240-2.115(2) states that cases may be dismissed if no action has occurred for ninety days. Commission Rule 4 CSR 240-2.115(3) allows the Commission to dismiss a party for failure to comply with a Commission order. For those reasons, the Commission will grant Staff's Motion to Revoke Authority.
