STAFF'S NOTICE OF WITHDRAWAL OF COMPLAINT

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and respectfully provides *Staff's Notice of Withdrawal of Complaint* to the Commission stating the following in support thereof:

- 1. On November 24, 2009, the Staff filed a *Complaint* against the Respondents, which asserted the unlawful provision of sewer service to the public for gain in Stone County, Missouri, without certification or other authority from the Commission.
- 2. On January 21, 2010, Canyon Treatment Facility, LLC, (Canyon Treatment) filed an Application for Permission, Approval and a Certificate of Convenience and Necessity (CCN) Authorizing it to Acquire, Construct, Install, Own, Operate, Manage, and/or Maintain a Sewer System for the Public Located in Stone County, Missouri. This Application case was assigned Commission Case No. SA-2012-0219.

- 3. On June 16, 2012, Staff asserted this case should remain open until a receiver has been appointed to oversee the daily operations of Canyon treatment or upon the Commission-approved purchase of the system.
- 4. On July 17, 2012, the Commission issued an *Order Approving Unanimous Stipulation and Agreement and Authorizing Transfer of Asset* in Commission Case No. SA-2012-0219. As a result, the system that is subject to this *Complaint* has been purchased by and transferred to Stone County Sewer District No. 1 (Sewer District).
- 5. Staff received confirmation that the transfer to the Sewer District was completed on July 23, 2012. Staff now withdraws the *Complaint*.

WHEREFORE, Staff respectfully submits this *Notice of Withdrawal of Complaint* and respectfully requests the Commission close this case and provide and any other relief as it deems necessary and appropriate.
