MOTION FOR LEAVE TO FILE AMENDED APPLICATION

COMES NOW Summit Natural Gas of Missouri, Inc. ("SNG" or "Company"), and, for its Motion for Leave to File Amended Application, respectfully states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On August 12, 2013, SNG filed an Application and Motion for Waiver requesting an Accounting Authority Order related to state and county changes in assessment methodology. On August 16, 2013, within ten days of the original filing, SNG filed its First Amendment to the Application.
- 2. On October 10, 2013, the Commission Staff and the Company held a conference call to discuss SNG's Application and related matters. During this call, two errors in Appendix 2 to SNG's originally filed Application were discussed. SNG is submitting this Motion for Leave and the Amended Application and Motion for Waiver attached hereto as a result of this discussion.
- 3. The Amended Application and Motion for Waiver attached hereto makes two corrections. The 2012 actual property tax expense for Gallatin (identified in Line No. 17 of Appendix 2) was adjusted from \$363,722 to \$181,886 to correct for an overstatement of property tax expense that occurred because previous year's taxes were included in the tax bill received from the county. Also, the 2012 actual property tax expense for Rogersville (also identified in Line No. 17 of Appendix 2) was adjusted from \$1,173,501 to \$1,210,767. The original error was

due to an administrative oversight. The correction of these two errors in Appendix 2 requires adjustment of the total taxes paid in 2012 and the total extraordinary property tax liability identified in paragraph 10 of the Application. The total SMNG and MGU 2012 property tax amount is \$2,176,833, and the total 2011 and 2012 extraordinary property tax liability is \$3,712,900. Attached hereto is SNG's Amended Application and Motion for Waiver and all appendices referenced therein.

WHEREFORE, SNG respectfully requests leave to file the Amended Application and Motion for Waiver attached hereto.
