CERTIFICATION TO PROVIDE BASIC LOCAL EXCHANGE TELECOMMUNICATIONS SERVICE, INTEREXCHANGE TELECOMMUNICATIONS SERVICE, NON-SWITCHED LOCAL TELEPHONE SERVICES, AND INTERCONNECTED VOICE OVER INTERNET PROTOCOL SERVICE

On June 13, 2018, PowerComm Broadband, LLC (PowerComm), filed a Second Amended Application for registration to provide telephone and interconnected Voice over Internet Protocol (VoIP) service in exchanges statewide in the state of Missouri, pursuant to Section 392.550 and Subsection 392.611.4, RSMo. On June 15, 2018, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation regarding the application and on June 20, 2018, provided a clarification to that recommendation.

The Commission has reviewed the application filed by the company and finds that the application and its attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo 2016, for registration. Additionally, the Staff stated in its clarification that Staff would assist PowerComm in either filing the appropriate tariffs with the Commission and/or ensuring that the necessary information for PowerComm's customers is provided on a publicly accessible website. Therefore, the Commission will register PowerComm's authority to provide various competitive telephone and VoIP services in exchanges statewide in the state of Missouri.

THE COMMISSION ORDERS THAT:

1. PowerComm Broadband, LLC is registered to provide interexchange and non-switched local exchange telecommunications service in all exchanges in the state of Missouri.

2. PowerComm Broadband, LLC is registered to provide interconnected Voice over Internet Protocol (VoIP) service in all exchanges in the state of Missouri.

3. PowerComm Broadband, LLC is granted authority to provide basic local exchange telecommunications service in all exchanges in the state of Missouri.


4. PowerComm Broadband, LLC is granted authority to provide the above services as a competitive carrier.

5. PowerComm Broadband, LLC shall work with the Staff of the Missouri Public Service Commission to either file the appropriate tariffs or provide the appropriate information to its customers on a publically accessible website.

6. This order shall be effective on July 1, 2018.
