Accompanying this letter for filing via the Commission's Electronic Filing and Information System (EFIS) are revised tariff sheets, which are designed to increase Ameren Missouri's gross annual electric revenues by approximately \$375.6 million, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes. Included in this increase is approximately \$102.9 million of anticipated increases in normalized net fuel costs above the net fuel costs included in base rates in the Company's last general rate proceeding.
