## CHARGEPOINT INC.'S STATEMENT OF SUPPORT OF STIPULATION

Comes now ChargePoint, Inc. ("ChargePoint") and for its statement of support submits the following to the Commission:

- 1. On August 8, 2019, Ameren Missouri, the Commission's Staff, and the Office of the Public Counsel filed a stipulation and agreement ("the Stipulation") which, if approved by the Commission, would allow Ameren Missouri to pursue additional electric vehicle ("EV") charging station incentive options, specifically the three additional EV sub-programs previously proposed in this proceeding (multifamily, public, and workplace charging), but as modified by the terms of the Stipulation.
- 2. ChargePoint fully supports the Stipulation because its programs will incent development of charging infrastructure in a way that will stimulate technology innovation, encourage competition in the market, and enable customer choice for EV charging equipment and services.
