STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation respectfully states:

- 1. In the attached Memorandum, labeled Appendix A, the Staff recommends that the Missouri Public Service Commission grant approval of the AMENDMENT TO THE INTERCONNECTION AGREEMENT BY AND BETWEEN ... SOUTHWESTERN BELL TELEPHONE, L.P. d/b/a ... AT&T MISSOURI AND COVAD COMMUNICATIONS COMPANY DIECA COMMUNICATIONS, INC. DIECA COMMUNICATIONS, INC. dba COVAD (Agreement Amendment) filed by DIECA Communications, Inc. d/b/a Covad Communications Company under the provisions of the federal Telecommunications Act of 1996. This Agreement Amendment amends the interconnection agreement in place between DIECA Communications, Inc. d/b/a Covad Communications, Inc. d/b/a Covad Communications, Inc. d/b/a Covad Communications Company and Southwestern Bell Telephone, L.P. d/b/a AT&T Missouri (Agreement) adopted in Case No. TO-2001-4. The Agreement Amendment adds provisions pertaining to local number portability.
- 2. The terms of the Agreement Amendment do not discriminate against telecommunications carriers not a party to the Agreement and are not against the public interest, convenience or necessity. Pursuant to 47 U.S.C. §252(e), the Commission is to approve a negotiated interconnection agreement unless the terms of the agreement discriminate against a

telecommunications carrier not a party to the agreement, or implementation of the agreement or any portion thereof is inconsistent with the public interest, convenience, or necessity.

3. The applicants have not submitted a serially numbered copy of the Agreement Amendment. Staff recommends the Commission direct the Parties to submit a serially numbered copy of the Agreement Amendment.

WHEREFORE, because the terms of the Agreement Amendment satisfy the standard set forth in 47 U.S.C. §252(e), Staff recommends the Commission approve the Agreement Amendment, and also direct the Parties to submit a serially numbered copy of the Agreement Amendment.
