STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On May 9, 2007, Aurora Communications, Inc. filed an application with the Commission for approval of an interconnection agreement with AT&T Missouri under the provisions of the federal Telecommunications Act of 1996.

2. Section 252(e) of the federal Telecommunications Act of 1996 provides that a State commission may only reject a negotiated agreement if it finds that the agreement discriminates against a telecommunications carrier not a party to the agreement or if the implementation of the agreement is not consistent with the public interest, convenience, and necessity. 47 U.S.C. §252(e).

3. In the attached Memorandum, which is labeled Appendix A, the Staff states that the interconnection agreement does not discriminate against a telecommunications carrier not a party to the agreement and is not against the public interest, convenience or necessity.

4. Staff notes that the applicants have not submitted a serially numbered copy of the Agreement. Therefore, Staff recommends the Commission direct the Parties to submit a serially numbered copy of the Agreement.

WHEREFORE, the Staff recommends the Commission approve the interconnection agreement pursuant to the Act, and direct the parties to submit a serially numbered copy of the

Agreement. Further, Staff recommends the Commission direct the parties to submit any modifications or amendments to the Agreement to the Commission for approval.


