On May 21, 2018, Union Electric Company d/b/a Ameren Missouri filed an application with the Missouri Public Service Commission seeking an order granting a Certificate of Convenience and Necessity (CCN) pursuant to section 393.170, RSMo 2016. The CCN would authorize Ameren Missouri to construct, own, and operate a wind generation facility to be constructed in Schuyler and Adair Counties in Missouri. Ameren Missouri's application also seeks approval of a Renewable Energy Standard Cost Recovery Mechanism (RESRAM), and a waiver of certain Commission rules. Ameren Missouri requests the Commission grant it a CCN no later than December 19, 2018.

The Commission will provide notice of the application to the general public and interested parties and set a deadline for intervention requests. If no movant is granted intervention, and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary for a determination of the application.<sup>1</sup> In addition, the Commission will schedule a procedural conference for June 8. The Commission will take up the procedural schedule

proposed by Ameren Missouri as well as the company's motion for a protective order at the conference.<sup>2</sup>
