On March 27, 2017, the Staff of the Missouri Public Service Commission (Staff) filed a Notice of Unanimous Disposition Agreement stating that the parties had reached a unanimous agreement in this matter. On April 17, 2017, Gladlo Water and Sewer filed tariff sheets purporting to comply with the terms of the agreement. The tariffs have an effective date of May 17, 2017. The Commission will set a date for a Staff recommendation and any objections to be filed with regard to the tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than April 27, 2017, the Staff of the Missouri Public Service Commission shall file a recommendation with regard to the tariff filing made on April 17, 2017.
2. Any other responses to the April 17, 2017 tariff filing shall be filed no later than April 27, 2017.

3. This order shall be effective when issued.
