On May 27, 2005, Chariton Valley Communication Corporation, Inc., filed an application for approval of its Interconnection Agreement with Southwestern Bell Telephone, L.P. d/b/a SBC Missouri. Also on May 27, 2005, Missouri RSA No. 5 Partnership d/b/a Chariton Valley Wireless filed an application for approval of its Interconnection Agreement with SBC Missouri. Subsequently, the Missouri Independent Telephone Group filed applications to intervene in both cases. To clearly understand and better address the MITG's concerns, the Commission will set this matter for a prehearing conference.

Because these matters involve similar parties and the same questions of law, the Commission will consolidate them for purposes of the prehearing conference.

IT IS THEREFORE ORDERED:

1. That a prehearing conference shall be held on July 13, 2005, beginning at **9:00** a.m. in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.
