AMERENUE'S RESPONSE TO ORDER DIRECTING FILING

COMES NOW Union Electric Company d/b/a AmerenUE ("AmerenUE") and for its response to the Missouri Public Service Commission's ("Commission") Second Order Directing Filing states as follows:

- 1. On September 15, 2005, AmerenUE filed an application in which it sought to abandon its certificate of public convenience and necessity to provide steam service to the Capitol Group of Buildings in Jefferson City, Missouri. AmerenUE alleged that it is no longer providing this service, and that the State of Missouri has constructed its own steam plant.
- 2. On February 10, 2006 the Commission issued its Second Order Directing Filing, in which it asked for additional information that it needs before making its decision. The Commission's questions, and AmerenUE's responses thereto, are as follows:

Question: What happened to the assets that were being used to provide steam heat?

Response: The assets that were used to provide steam service to the Capitol Group of Buildings were retired in October, 1999 resulting in a loss of \$337,015.52. The idled steam plant is still on AmerenUE's premises.

Question: If a transfer of assets was made, in what case did the Commission approve that transfer?

Response: No transfer of assets was made.

Question: Are there any accounts remaining on AmerenUE's books related to the steam

heat assets?

Response: No.

WHEREFORE, AmerenUE respectfully requests that the Commission accept this response and issue its order permitting AmerenUE to abandon its provision of steam service and cancel the related tariffs.
