ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Midwestern Services, L.C. d/b/a Midwestern Tel (Midwestern) applied to the Public Service Commission on February 26, 1998, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMo 1994¹. Midwestern asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Midwestern is a Missouri limited liability company, with its principal office located at 3809 Castleman, Suite 100, St. Louis, Missouri 63110.

The Commission issued a Notice of Applications and Opportunity to Intervene on March 3, directing parties wishing to intervene to file their requests by March 18. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. <u>State ex rel. Rex Deffenderfer</u> <u>Enterprises, Inc. v. Public Service Commission</u>, 776 S.W.2d 494, 496

(Mo. App. 1989). Since no one has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

Midwestern filed a proposed tariff in conjunction with its application and filed substitute sheets on March 19. The tariff's effective date is April 13. Midwestern's tariff describes the rates, rules, and regulations it intends to use, identifies Midwestern as a competitive company, and lists the waivers requested. Midwestern intends to provide interexchange telecommunications services including 1+ direct dial, 800/888/877 number, directory assistance, operator services, and travel card services.

In its Memorandum filed on April 2 the Staff of the Commission stated that Midwestern's proposed services are similar to existing IXC offerings. Staff recommended that the Commission grant Midwestern a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on April 13.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and Midwestern should be granted a certificate of service authority. The Commission finds that the services Midwestern proposes to offer are competitive and Midwestern should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Midwestern's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on February 26 shall be approved as amended to become effective on April 13.

IT IS THEREFORE ORDERED:

1. That Midwestern Services, L.C. d/b/a Midwestern Tel is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.

2. That Midwestern Services, L.C. d/b/a Midwestern Tel is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
