STAFF'S STATEMENT OF POSITION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and states:

- 1. On September 7, 2000, the Missouri Public Service Commission (Commission) issued an Order Adopting Procedural Schedule which, *inter alia*, directed the filing of a list of issues on December 20, 2000, and the filing of statements of position on January 3, 2001.
- 2. On December 20, 2000, the Staff filed, on behalf of the parties, an agreed upon list of issues to be heard.
 - 3. The Staff's position on those issues follows:
- 1. Is SWBT properly making Local Plus service available for resale to IXCs and CLECs?

ANSWER: No. SWBT does not make Local Plus service available on a UNE basis and it does not provide or permit others to resell the service when SWBT does not provide the local switching.

2. Who should be responsible for paying terminating access charges to third-party LECs when:

VOV

a. Local Plus is being offered through pure resale of SWBT's retail Local Plus Offering?

ANSWER: SWBT

b. Local Plus is being offered through a facility-based carrier's purchase of unbundled switching from SWBT?

ANSWER: SWBT

c. Local Plus is being offered through a facility-based carrier's own switch?

ANSWER: Until the issues of how such traffic would be tracked and recorded and how SWBT would price Local Plus service on a UNE basis, SWBT should be responsible for paying terminating access.
