1. On September 25, 2007, the Commission issued its Order Directing Filing Of Status Reports which directed that SMNG file a status report regarding the financing necessary to

complete the projects conditionally approved in this case on the fifth day of every month until SMNG submits its financing proposal to the Commission.

2. In response to the Order Directing Filing Of Status Reports, SMNG wishes to inform the Commission that it has selected the equity and debt investor for the proposed financing transaction and has filed with the Commission and the parties a Summary of the Proposed Terms Of Equity and Debt Financing which was attached to SMNG's pleading filed in this matter on October 5, 2007. SMNG is in the process of preparing a Second Amended Financing Application in this matter to conform its application to the final terms and conditions that have been negotiated with its equity and debt investor which it intends to file in the near future.

WHEREFORE Southern Missouri Gas Company, L.P. d/b/a Southern Missouri Natural Gas respectfully requests that the Commission accept its Status Report in response to the Order Directing Filing of Status Report issued on September 25, 2007.
