In the attached Memorandum, which is labeled Appendix A, the Staff states that the proposed facilities-based interconnection agreement (Agreement) between SBC Advanced Solutions, Inc., and Southwestern Bell Telephone, L.P., d/b/a SBC Missouri meets the standards set forth in Section 252(e) of the Federal Telecommunications Act of 1996 (47 U.S.C. § 252 (e)) in that the Agreement does not discriminate against telecommunications carriers not party to the Agreement and is not against the public interest, convenience, or necessity.

WHEREFORE, Staff recommends that the Missouri Public Service Commission grant approval of the Agreement pursuant to the Act, and direct the parties to submit any modifications or amendments.
