**LIST OF ISSUES AND ORDER OF  
OPENING STATEMENTS, WITNESSES AND CROSS-EXAMINATION**

**COMES NOW** the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), Big River Telephone Company, LLC ("Big River"), Southwestern Bell Telephone Company, d/b/a AT&T Missouri ("AT&T Missouri") (collectively, "the parties"), and in accordance with the Commission's August 20, 2012, Order Setting Procedural Schedule and Establishing Additional Procedural Requirements ("Order"), respectfully submits the following List of Issues, List of Witnesses, Order of Witnesses, Order of Cross-Examination, Order of Opening Statements, Time Limits on Opening Statements and Cross/Redirect Examinations.

**Issues for Commission Determination**

1. Should the traffic which Big River has delivered to AT&T Missouri over the local interconnecting trunks for termination, and for which AT&T Missouri has billed Big River access charges since January, 2010 under Billing Account Number 110 401 0113 803 ("BAN 803"), be classified as interconnected VoIP traffic, enhanced services traffic, or neither?

2. What charges, if any, should apply to the traffic referenced in Issue No. 1?

**Order of Opening Statements**

The parties propose the following order of opening statements: Big River, AT&T Missouri, and Staff.
