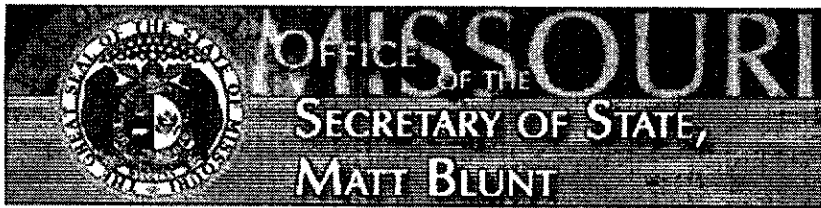

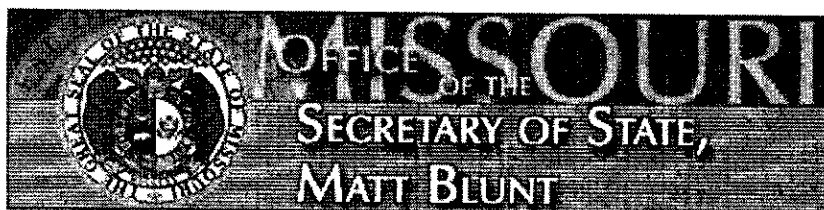

ORDER DIRECTING FILING

On February 6, 2004, the Staff of the Commission filed its complaint against TelePlus, Inc. On February 11, 2004, the Commission issued its Notice of Complaint, and attempted to serve TelePlus at its last known address and TelePlus's Registered Agent by certified mail.

On February 23, 2004, the Commission received the returned certified mail sent to TelePlus's Registered Agent with the designation "Not Deliverable as Addressed, Unable to Forward." On March 12, 2004, the Commission received the returned certified mail sent to TelePlus's last known address with the designation "Unclaimed".

If a corporation fails to maintain a registered agent in Missouri, then the Secretary of State becomes the registered agent for the purpose of service of notice.¹ The Commission will order Staff to serve the Missouri Secretary of State with notice of the complaint.

The Commission will also order Staff to file proof of service. The Commission will allow ten days for a response after proof of service is filed.

IT IS THEREFORE ORDERED:

1. That the Staff of the Commission shall serve the Missouri Secretary of State with notice of its complaint against TelePlus, Inc.
2. That the Staff of the Commission shall file proof of service with the Commission.
3. That the Commission will allow ten days from the date the Missouri Secretary of State is served for a response.
4. That this order shall become effective on March 25, 2004.

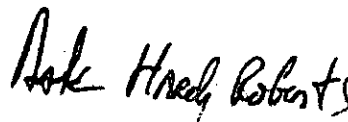

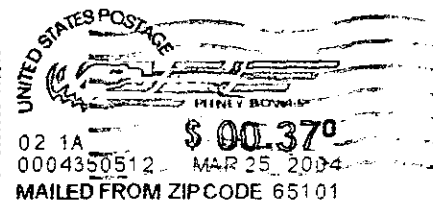
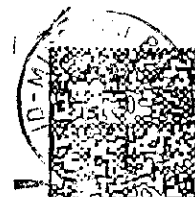
