MOTION TO ACCEPT CERTIFICATE OF CORPORATE GOOD STANDING

CoreComm Missouri, Inc. ("CoreComm") hereby submits its Motion to Accept Certificate of Corporate Good Standing and states to the Missouri Public Service Commission ("Commission") as follows:

1. On December 10, 2002, the Staff of the Commission asked the Commission to open a case and to cancel the certificate of service authority and tariff held by CoreComm. CoreComm filed a Reply on December 20, 2002, requesting that the Commission deny Staff's requests.

2. On December 31, 2002, the Commission issued its Order Setting Prehearing Conference and Requiring Filing of Procedural Schedule. The parties met in prehearing on January 21, 2003. A procedural schedule was to be filed January 28, 2003.

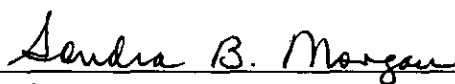
3. At prehearing, counsel for CoreComm stated that CoreComm was in the process of obtaining a rescission of administrative dissolution from the Missouri Secretary of State and expected to be able to provide a Certificate of Corporate Good Standing to the Commission shortly.

4. Attached to this pleading as Exhibit A is a Certificate of Corporate Good Standing for CoreComm. Since the reinstatement of the corporation in Missouri was the only matter

outstanding, CoreComm requests that the Commission accept this document and dismiss Staff's request to cancel CoreComm's certificate of service authority and tariff.

Wherefore, CoreComm respectfully requests that the Commission grant its Motion to Accept Certificate of Corporate Good Standing and dismiss Staff's request to cancel its certificate of service authority and tariff.
