SUBJECT: Staff Recommendation on Atmos Energy's Tariff Sheets Filed to Comply with the
Commission's Order Approving Stipulation and Agreement

DATE: August 19, 2010

On August 18, 2010, the Missouri Public Service Commission (Commission) issued its Order Approving Stipulation and Agreement (Order) in Case No. GR-2010-0192. This Order approved a natural gas general rate increase for certain customers of Atmos Energy Corporation (Atmos or Company).

Atmos filed tariff sheets on August 18, 2010 to comply with the Order.

In its letter of transmittal accompanying the August 18, 2010 compliance filing, Atmos is requesting an effective date of September 1, 2010, which is less than the standard 30-day period, but which complies with the Commission's Order.

The Commission's Energy Department - Tariffs/Rate Design Staff (Staff) has reviewed each of the tariff sheets, as filed by Atmos on August 18, 2010, and is of the opinion that these sheets are in compliance with the Commission's Order. Therefore, Staff recommends that the tariff sheets filed August 18, 2010, be approved to become effective on and after September 1, 2010.
