On March 16, 2012 the above referenced telephone companies filed tariff sheets in accordance with a Federal Communications Commission (FCC) Report and Order and Further Notice of Proposed Rulemaking in Docket No. 11-42, *In the Matter of Lifeline and Link Up Reform and Modernization* (Report and Order).

The Telecommunications department has examined the proposed tariff sheets and recommends approval. The proposals contain a description of the new federal support guidelines, such as the new criterion of customer income at or below 135% of the Federal Poverty Guidelines. The proposals also either: (1) list the actual state or federal support monetary discounts or, (2) state that the relevant state/federal discounts will be offered. Moreover, the proposals reflect elimination of the Link Up program which, again, has come about as a result of the FCC's Report and Order.

The Staff is unaware of any other matter that affects or that would be affected by this matter. Staff recommends approval at the Commission's earliest convenience.
