Subject: Staff Recommendation to Approve a Proposed Name Change and Adoption Notice

Date: September 28, 1999

On July 26, 1999, Harcourt Telco, L.L.C., (Harcourt), a competitive telecommunications company, filed a Notification of Registration of Fictitious Name and attached a copy of its Registration of Fictitious Name from the Missouri Secretary of State authorizing use of the fictitious name Maverix.com, Inc. Harcourt was certificated by this Commission to provide interexchange and local exchange telecommunications services in Case No. TA-99-310.

On August 16, 1999, the Commission issued an Order Directing Filing. The Order states that the Commission can not recognize the name change until Harcourt files an adoption notice and a tariff title page. The Commission ordered Harcourt to file both items with effective dates of no later than September 15, 1999. On September 14, 1999, Harcourt filed a Notice of Adoption of Tariff and included a tariff sheet entitled "Original Adopted Title Sheet". The tariff sheet had an issued date of August 17, 1999 and an effective date of September 15, 1999. Although the Commission's order directed Harcourt to file both a title sheet and an adoption notice, Harcourt filed only the tariff sheet entitled "Original Adopted Title Sheet". The Telecommunications Department Staff (Staff) contacted Harcourt's attorney to advise that the "Original Adopted Title Sheet" was deficient. At the request of the Staff, Harcourt filed a substitute tariff sheet entitled "Original Adoption Notice Page" on September 17, 1999. The Commission issued a Notice Regarding Filing on September 27, 1999 stating that Harcourt does not need to file a tariff title page. Staff believes that Harcourt's amended adoption notice is in compliance with the Commission's order and recommends the Commission issue an order to amend Harcourt's certificate of service authority to reflect the name change and approve the following tariff page:
