
On February 1, 2005, the Staff of the Commission filed a motion asking the Commission to cancel the certificates of service authority to provide interexchange telecommunications and private pay telephone services that were granted to Eagle Communications Group, Inc. in Case No. TA-99-573. Staff's motion indicates that Eagle has failed to file its annual reports for 2001, 2002, and 2003. Staff also reports that Eagle has failed to provide the Commission with a current address. Because of these failures, Staff asks the Commission to cancel Eagle's certificates and accompanying tariff.

The Commission will order Eagle to respond to Staff's motion. If Eagle fails to respond, Staff's motion may be granted without further notice.

**IT IS THEREFORE ORDERED:**

1. That Eagle Communications Group, Inc., shall file a response to Staff's Motion to Cancel Certificates of Service Authority and Accompanying Tariff no later than February 22, 2005.
2. That this order shall become effective on February 2, 2005.


