



ORDER GRANTING DEFAULT

Syllabus: This order finds Tenet Healthsystem DI d/b/a Orchard House Partnership in default.

On February 18, 2004, the Staff of the Commission filed a complaint against Orchard House. In that complaint, Staff alleges that Orchard House did not file its 2002 annual report. Staff's complaint requests authority, as provided in Section 386.600, RSMo 2000, to bring a penalty action in circuit court against Orchard House for its failure to file its annual report.

On February 23, the Commission issued a Notice of Complaint that informed Orchard House of Staff's Complaint and directed it to file an answer within 30 days of the date of the notice. The Notice of Complaint was delivered to Orchard House by

certified mail, return receipt requested, on February 25. Orchard House's answer was due no later than March 24. Orchard House did not file an answer.

Commission Rule 4 CSR 240-2.070(9) provides that if a respondent fails to timely respond to a complaint, the Commission may deem the complaint admitted, and may enter an order granting default.¹ Orchard House has failed to file a timely response to Staff's complaint. Therefore, the Commission finds that Orchard House is in default and that Staff's allegations are admitted.

IT IS THEREFORE ORDERED:

1. That default is hereby entered against Respondent, Tenet Healthsystem DI, d/b/a Orchard House Partnership, and the averments of Staff's complaint are deemed admitted.

2. That the General Counsel of the Commission is directed to bring a penalty action against Tenet Healthsystem DI, d/b/a Orchard House Partnership, in circuit court.

3. That this order shall become effective on April 22, 2004.

¹ That rule also allows the Commission to set aside a default order if the respondent files a motion to set aside the order within seven days of issue date of the order granting default, and if the Commission finds good cause for the respondent's failure to timely respond to the complaint.

4. That this case shall be closed on April 23, 2004.
