PROGRESS REPORT AND MOTION FOR EXTENSION OF TIME OF THE SMALL MISSOURI LOCAL EXCHANGE COMPANIES

COME NOW the Complainants in the above-captioned case, and for their progress report and motion for extension of time, state to the Missouri Public Service Commission (Commission) that: (1) negotiations are ongoing and appear to be nearing completion; and (2) Complainants request an additional ten (10) days to complete negotiations.

- 1. On May 20th, 2003, the parties agreed to seek a negotiated agreement regarding the nature of the traffic that is being delivered to Complainants by the Respondents. On that same day, the Commission issued an *Order* directing the parties to file pleadings that advise the Commission as to the progress of their discussions.
- 2. Complainants and Respondents continue to work towards developing interMTA factors, and Complainants believe that they are close to an agreement. Therefore, Complainants seek an additional ten (10) days (until June 30, 2003) to negotiate interMTA factors.
- 3. Complainants have communicated with Respondents and Staff about the extension of time, and Respondents and Staff to not object to the extension.

WHEREFORE, Complainants respectfully request that the Commission allow Complainants an additional ten (10) day period to reach an agreement on interMTA factors and report back to the Commission.
