## **CERTIFICATION TO PROVIDE TELECOMMUNICATION SERVICES**

On August 20, Metro Fibernet, LLC d/b/a MetroNet (“the Company”) pursuant to Section 392.550, RSMo, filed an application for certificate of service authority to provide Basic Local Telecommunications Service and Interexchange Telecommunication Service in the following exchanges:

Jefferson City and O’Fallon

The Commission has reviewed the application filed by the Company and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the Office of the Commission about any substantive issue connected to the filing within 60 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

**THE COMMISSION ORDERS THAT:**

1. MetroNet is granted certification to provide Basic Local Telecommunications Service and Interexchange Telecommunication Service in the exchanges set forth in the affidavit attached to the application and restated above.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on September 10, 2021.
4. This file may be closed on September 11, 2021.
