This filing is being made in accordance with the Commission's decision in Case No. TO-99-254 (PTC Plan) and Case No. TO-99-519 (IntraLATA Dialing Parity Plan). Please note also that this filing is identical to the filing which initiated Case No. TT-2001-117 but which was withdrawn on December 22, 2000, at the suggestion of the Commission.
