## MOTION FOR EXTENSION OF TIME TO FILE 2002 ANNUAL REPORT

Comes Now Trigen-Kansas City Energy Corporation ("Trigen"), by and through counsel, pursuant to 4 CSR 240-10.080 and 4 CSR 240-2.015, and for its Motion for Extension of Time to File 2002 Annual Report respectfully states as follows:

- 1. Trigen is investigating the need for potential adjustments to certain of its records and accounts (such as its plant records and depreciation reserve accounts) and does not anticipate completion of such investigation in time for filing its 2002 Annual Report by April 15, 2003. This work is continuing and completion of the investigation has been delayed due to the reorganization of administrative functions and the recent relocation of accounting personnel and records. Therefore, rather than wait until after the fact to request leave to late file its annual report, Trigen is making this filing at this time.
- 2. 4 CSR 240-10.080(8) and 4 CSR 240-2.015 (to the extent applicable) allow a utility to request an extension of time within which to file the annual report, provided the reasons therefor are stated. Counsel has attempted to do so above, and to make this filing in advance of April 15 so the deadline will not simply pass without a filing. At this time Trigen believes that it will need until June to file its annual report given the need to complete the investigation referenced above and any associated

adjustments prior to filing its annual report. Trigen submits that the Commission should find good cause exists to grant it until June 2, 2003 to file its annual report.

WHEREFORE, Trigen respectfully moves the Commission to grant this Motion for Extension of Time to File 2002 Annual Report and requests the Commission issue an order which grants Trigen until June 2, 2003, to file its annual report.
