## **STATUS REPORT**

**COMES NOW**, Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("Evergy Missouri Metro") and Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("Evergy Missouri West") (collectively "Evergy" or the "Company") and for this *Status Report* ("Status Report") respectfully states as follows:

1. On October 30, 2020, the Missouri Public Service Commission ("Commission") issued its *Order Granting Motion to Suspend Procedural Schedule* ("Order") which directed the parties to file a status report by December 4, 2020, advising the Commission whether or not it is believed that ongoing settlement discussions will result in settlement. This pleading is being filed in response to the *Order*.
