


COME NOW Respondent U. S. Cellular in the above referenced case and for its



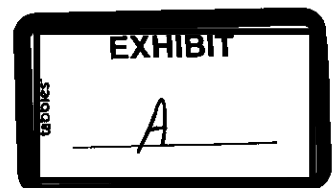

5. Petitioners request that the commission grant them leave to be permitted to appear and participate in the above referenced case.




