

The correction is in the first paragraph of the Notice, which should have read as follows:

("MoKan"), collectively referred to herein as "Petitioners", and hereby notify the Commission and the other parties to this docket that Petitioners have elected not to file direct testimony on January 9, 2004, but instead have elected to accept that, except where there is a stipulation between Alma, Choctaw, or MoKan and a wireless carrier providing to the contrary, zero percent of the traffic at issue terminating to these three Petitioners be determined to be interMTA traffic.


