The Respondents' answers are presently due on November 4, 2009. On October 30 and November 2, 2009, respectively, Big River Telephone Company and Qwest Communications Company, LLC, filed requests for additional time, to November 13, 2009, to file their responses. Both companies state that Southwestern Bell Telephone Company, L.P., d/b/a AT&T Missouri, does not object to the extensions.

The Commission will grant the requested extensions and will, on its own motion, extend the response filing deadline for all the remaining Respondents and the date for the Commission Staff's report of its investigation.

THE COMMISSION ORDERS THAT:

1. Big River Telephone Company's Request for Additional Time to File Its Response is granted.

2. Qwest Communications Company, LLC's Request for Additional Time to File Response is granted.

3. The filing deadline for responses to Southwestern Bell Telephone Company, L.P., d/b/a AT&T Missouri's complaint is extended for all Respondents to no later than November 13, 2009.

4. The Staff of the Commission shall file a report of its investigation in this matter no later than December 1, 2009.

5. This order shall become effective upon issuance.
