SUBMISSION IN COMPLIANCE WITH  
STIPULATION AND SETTLEMENT AGREEMENT  
AND COMMISSION ORDER

COMES NOW M.L.M. Telecommunications, Inc., d/b/a Ameritel, Your Phone Company (M.L.M./Ameritel), by and through counsel, and for its Submission in Compliance with Stipulation and Settlement Agreement and Commission Order, states as follows:

1. On June 3, 2003, the Commission issued its ORDER APPROVING STIPULATION AND SETTLEMENT AGREEMENT, approving the unanimous Stipulation and Settlement Agreement (Agreement) filed in this case on April 28, 2003. One of the terms of the Agreement was for M.L.M./Ameritel to remit a payment in the amount of \$3,000.00 to the Public School Fund of the State of Missouri, under Section 166.011 RSMo., for the sole purpose of settling the Complaint, with payment to be made upon Commission approval of the Agreement. The Agreement also provided that "Ameritel shall file a copy of the check and a return receipt in the Commission's case file to demonstrate compliance with this provision."

2. M.L.M./Ameritel has now submitted the payment according to the terms of the Agreement and hereby files proof of the payment with the Commission. Attached as Exhibit A is a copy of each of the following: a) the cover letter from M.L.M./Ameritel to the Department of Elementary and Secondary Education, b) the check in the amount of

\$3000.00, and c) the return receipt from the US Postal Service.

3. The Agreement also provided that "If the Commission accepts the specific terms of this Agreement, and upon compliance of the parties with the terms thereof, the Complaint shall be dismissed." The Commission's ORDER APPROVING STIPULATION AND SETTLEMENT AGREEMENT provided for that dismissal by stating "Staff shall accomplish the dismissal by filing in this case a notice of dismissal with prejudice." Thus, upon Staff's filing its notice of dismissal, it is M.L.M./Ameritel's understanding that this case may be closed.

WHEREFORE, M.L.M. respectfully submits this Submission in Compliance with Stipulation and Settlement Agreement and Commission Order.

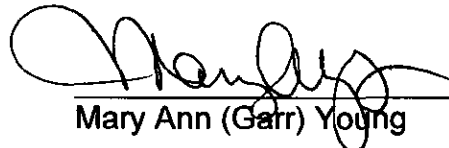
