## COMPLAINANTS' MOTION FOR A SECOND EXTENSION OF TIME WITHIN WHICH TO FILE RESPONSE TO MOTION TO DISMISS

Come now AT&T Communications of the Southwest, Inc., Birch Telecom of Missouri, Inc. TCG Kansas City, Inc. and TCG St. Louis, Inc. (hereinafter collectively "Complainants"), by and through their attorneys, Newman, Comley & Ruth P.C., and pursuant to 4 CSR 240-2.050(3) submit the following to the Commission:

- 1. On August 18, 2003 Southwestern Bell Telephone, L.P., d/b/a SBC Missouri ("SBC") filed its motion to dismiss in the referenced matter. On August 26, 2003, Complainants filed for an extension of time to file a response to SBC's motion, and on August 28, 2003 the Commission granted that request by extending the time to file to September 4, 2003.
- 2. The author of Complainants' response to SBC's Motion to Dismiss is Katherine K. Mudge, who, over the holiday weekend, fell ill unexpectedly. Although her condition is improving, her physicians have prescribed a series of medical tests and procedures over the next several days, all of which will interfere with her efforts to finalize the response for filing.
