COMES NOW Respondent CenturyTel of Missouri, LLC ("CenturyTel"), pursuant to Missouri Public Service Commission ("Commission") Rule 4 CSR 240-2.070(7), and for its Motion To Further Amend Deadline For Filing Answer respectfully states as follows:

1. On July 25, 2003, the Commission issued its Order Setting Prehearing Conference and Order Amending Deadline for Respondent's Answer, wherein the Commission set a prehearing conference in this matter for Wednesday, July 30, 2003, and ordered that the answer of the Respondent shall be filed not later than 4 p.m. on August 6, 2003.

2. Pursuant to the Order, the parties appeared and participated in the prehearing conference, and representatives of Complainant, Respondent and the Staff of the Commission participated in additional off-the-record discussions to consider procedural and substantive matters which may aid in the disposition of the issues presented in the instant complaint. 
that said discussions are proving beneficial and, as a result, it appears that there is no current need for a time-sensitive hearing schedule.
