**MOTION TO OPEN CASE AND CANCEL CERTIFICATES OF SERVICE
AUTHORITY AND ACCOMPANYING TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and pursuant to Section 392.410.5, RSMo (2000) ¹ moves that the Missouri Public Service Commission (the Commission) cancel the certificates of service authority and accompanying tariff of Advanced Telemanagement Group, Inc. (Advanced or the Company). In support of its Motion, Staff states as follows:

1. On November 26, 2003, the Commission granted Advanced Telemanagement Group, Inc. certificates of service authority to provide both intrastate interexchange and nonswitched local exchange telecommunications services and approved the Company's tariff².
2. On July 21, 2008, Staff received a communication from the Company indicating that as of September, 2006 the Company had ceased doing business and requesting that the Commission close its "account". See Exhibit A.
3. Advanced is an Arizona corporation, previously authorized by the Missouri Secretary of State to conduct business in the State of Missouri. Information currently available from the Missouri Secretary of State indicates that the Company was administratively dissolved

in Missouri on December 17, 2008. Similar information available from the State of Arizona indicates that as of November 20, 2008 the Company was in the process of dissolution in Arizona.

4. As of the date of the filing of this motion, the Company's registered agent according to the Missouri Secretary of State is:

5. The Company has provided the following contact information to the Commission:

6. The Commission has the authority to cancel the certificate of service authority of a telecommunications corporation pursuant to Section 392.410.5, which provides that "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

7. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

8. The Company currently has one (1) formal complaint pending with the Commission, Case No. XC-2009-0347, based upon the Company's failure to submit a 2007 annual report.

9. ATG is current in the payment of its Commission assessments.

WHEREFORE, Staff recommends the Commission cancel the certificates of service authority of Advanced Telemanagement Group, Inc. to provide both intrastate interexchange and

nonswitched local exchange telecommunications services and the accompanying tariff, Missouri
P.S.C. Mo. Tariff No. 1.


