MOTION FOR EXPEDITED TREATMENT

COMES NOW Atmos Energy Corporation ("Atmos" or "Company"), pursuant to Missouri Public Service Commission ("Commission") Rules 4 CSR 240-2.065(2) and 4 CSR 240-2.080(16), and respectfully submits its Motion for Expedited Treatment in the above-referenced matter. In support of its Motion, Atmos respectfully states as follows:

1. On this date, Atmos filed revised tariff sheets reflecting the introduction of a new program component to the Atmos Energy Conservation and Efficiency Program, **Energize Atmos Energy Homes**, in accordance with the Order Approving Stipulation and Agreement in Case No. GR-2010-0192, as well as recent decisions of the Energy Efficiency Advisory Group to amend the existing rebate program. This tariff filing was assigned Tracking No. JG-2011-0517, and a copy is attached and incorporated herein by reference.

2. These revised tariff sheets reflect a thirty (30) day effective date, May 11, 2011. However, in order to allow Atmos to proceed with the administrative actions necessary to effectuate and implement Energize Atmos Energy Homes, and to permit the amended rebate terms to be effectuated as soon as possible, Atmos is respectfully requesting expedited treatment of these tariff revisions.

3. In accordance with Commission Rule 4 CSR 240.2-080(16), Atmos requests that the Commission act by its April 27, 2011 Agenda Meeting. As stated

above, expeditious approval of these tariff revisions will benefit Atmos' customers and the general public by providing Atmos with the authority to proceed with the administrative actions necessary to effectuate and implement this new program component. Similarly, the amended terms of the existing rebate program will be available to participating customers sooner, all to their benefit. There will be no negative effect on Atmos' customers or the general public if the commission acts as requested herein. As the subject revised tariff sheets were filed this date, this pleading was filed as soon as it could have been.

4. Atmos is authorized to state that the Staff, the Office of the Public Counsel and the Missouri Department of Natural Resources do not object to the specific relief requested in this motion.

WHEREFORE, Atmos Energy Corporation respectfully submits its Motion for Expedited Treatment and respectfully requests that the Commission grant the relief requested herein.
