NOTICE OF APPLICATION FOR EXPANSION OF CERTIFICATE OF SERVICE AUTHORITY AND ORDER DIRECTING FILING

On September 19, 2008, XO Communications Services, Inc., filed an application to expand its basic local exchange telecommunications service to include the provision of basic local exchange telecommunications service in all exchanges throughout the state of Missouri. XO has previously been issued a certificate to provide basic local exchange telecommunications service in the service territories of Southwestern Bell Telephone Company, n/k/a AT&T, CenturyTel of Missouri, LLC, and Sprint Missouri, Inc. XO also has been granted certificates of service authority to provide interexchange telecommunications services and non-switched local exchange telecommunications services (limited to providing dedicated, non-switched local exchange private line services) throughout the state of Missouri.

XO requests that the company and its services remain classified as competitive.

XO has also requested that the Commission grant it a waiver of the following:

The Commission shall grant the application to expand a certificate to provide basic local telecommunications service of an alternative local exchange carrier (ALEC) certificated prior to August 28, 2008, within 30 days of the request so long as the ALEC is in good standing with the Commission in all respects. Therefore, if XO meets the criteria, the Commission must act no later than October 19, 2008.

The Commission shall direct its Data Center to send notice of this application to each certificated telecommunications company. Any proper person who wishes to request a hearing on this matter shall do so as directed below. If no proper person requests a hearing, the Commission may make its decision based on the verified application and other filings in the case. ²

In addition, the Commission would be aided by a recommendation from its Staff.

Therefore, the Commission shall direct its Staff to file a recommendation as directed below.

IT IS ORDERED THAT:

- 1. The Data Center of the Commission shall send a copy of this notice to each certificated telecommunications company in the state of Missouri.
 - 2. Any request for hearing shall be filed no later than October 3, 2008.
- 3. The Staff of the Missouri Public Service Commission shall file its recommendation no later than October 3, 2008.
 - 4. This order is effective upon issuance.
