1. On January 13, 2010, Everest Midwest Licensee LLC d/b/a SureWest ("SureWest") filed a notice with the Commission that it would be henceforth known as SureWest Kansas Licenses, LLC. In addition, SureWest filed revised tariff sheets for its Missouri P.S.C. Tariffs 4, 5 and 6, to reflect the new name.

2. Rule 4 CSR 240-2.060 establishes filing requirements for certificated company name changes; as noted in the Staff Recommendation, attached hereto as Attachment A, the Company has complied with the rule.
