STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its recommendation respectfully states:

1. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Missouri Public Service Commission (Commission) take notice of the adoption by Cellco Partnership Wireless (VAW) LLC d/b/a Verizon Wireless, St. Joseph Cell Telco d/b/a Verizon Wireless, and Cybertel Cellular Telephone Company d/b/a Verizon Wireless (Verizon Wireless) of the Interconnection and Reciprocal Compensation Agreement between Spectra Communications Group, LLC and WWC License LLC., (Agreement) pursuant to § 252(i) of the Telecommunications Act of 1996 (Act).

2. The Commission approved the Agreement in Case No. TK-2003-0306. In the Commission's *Order Approving Interconnection Agreement* of May 1, 2003, the Commission stated that the Agreement meets the standards set forth in Section 252(e) of the Act in that it does not discriminate against telecommunications carriers not party to the Agreement and that its implementation is not against the public interest, convenience, or necessity.

3. Therefore, Staff recommends that the Commission take notice of the adoption of the Agreement pursuant to the Act. In addition, the Staff recommends that the Commission

direct the Parties to file any modifications or amendments to the Agreement with the Commission for approval.

WHEREFORE, because the terms of the Agreement satisfy the standard set forth in 47 U.S.C. §252(e), Staff recommends the Commission take notice of the adoption by Cellco Partnership Wireless (VAW) LLC d/b/a Verizon Wireless, St. Joseph Cell Telco d/b/a Verizon Wireless, and Cybertel Cellular Telephone Company d/b/a Verizon Wireless (Verizon Wireless) of the Interconnection and Reciprocal Compensation Agreement between Spectra Communications Group, LLC and WWC License LLC.; and direct the parties to submit any future modifications or amendments to the Agreement to the Commission for approval.
