Dear Mr. Henderson:

We previously advised you that, in an effort to streamline our corporate structure, Time Warner Cable Inc. ("Time Warner Cable") would be merging certain of its subsidiaries into other Time Warner Cable subsidiaries resulting in the transfer of the state-issued franchise(s) for the communities listed on Attachment A.

The purpose of this letter is to provide amended notice to our January 5, 2009 letter, as required by RSMo § 67.2701, that the transfer occurred as of December 31, 2008. Two communities have been added to the list of transfers. The new Franchisee, Time Warner Entertainment-Advance/Newhouse Partnership, will comply with the terms of the state-issued franchise(s), subject to applicable law.
