MOTION TO CANCEL CERTIFICATE OF SERVICE
AUTHORITY AND ACCOMPANYING TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (Staff), and moves that the Commission cancel the certificate of service authority it has granted to Telliss, LLC to provide intrastate inter-exchange telecommunications services in Missouri and non-switched local exchange telecommunications services, as well as its tariff. In support of its Motion, Staff respectfully states as follows:

1. On May 18, 2002, the Missouri Public Service Commission (Commission) issued an order granting a certificate of service authority to provide intrastate interexchange telecommunications services and non-switched local exchange telecommunications services to Telliss, LLC ("Telliss") in Case No. TA-2002-474, and approved its tariff, P.S.C. Mo. Tariff No. 1, in the same case.

2. Telliss has asked the Commission to cancel its certificate of service authority because it has sold its Missouri operations to First Choice Technology, Inc., and no longer does business in this State. See Appendix A. This was confirmed in a telephone conversation on December 10, 2007.

3. Telliss owes no annual reports or assessments. One complaint was submitted, on April 20, 2005 with respect to the company since the commencement of the Electronic Filing and Information System.

4. Telliss reported no Missouri jurisdictional revenues for 2006.

5. First Choice Technology, Inc., holds a certificate of service authority to provide inter-exchange telecommunications service in the State of Missouri. This certificate is *not* affected by this filing, and should remain active.

6. Because Telliss has requested cancellation of its certificate to do business and because it is not providing telecommunications service in Missouri, the Staff recommends that the Commission issue an order canceling Telliss, LLC's certificate of service authority, as well as its tariff.

7. The Commission has the authority to cancel a telecommunications corporation certificate pursuant to Section 392.410.5 RSMo (Supp. 2006), which provides:

“Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo.App. 1989).

8. This pleading is being served on the address provided by the company to the Commission via certified mail, as well as upon its Missouri registered agent and the address of the purchaser provided to the Commission by Telliss.

WHEREFORE, the Staff recommends the Commission cancel the certificate of service authority of Telliss, LLC to provide intrastate interexchange telecommunications services and non-switched local exchange telecommunications services; and also its tariff, P.S.C. Mo. Tariff No. 1.
