**STAFF RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission and for its recommendation states:

1. On December 1, 2010, the Commission received tariffs bearing an effective date of December 31, 2010, which reflects the name change of Global Crossing Telemanagement, Inc. to Global Crossing Local Services, Inc., pursuant to an internal reorganization.

2. Rule 4 CSR 240-2.060 establishes filing requirements for certificated company name changes; as noted in the attached Staff Memorandum, the Company has complied with the rule, including the customer notice provisions. No entities intervened to oppose the name change. The Company is not delinquent in any required filings with the Commission. The filed revised tariff sheets are compliant with Commission rules.

WHEREFORE, the Staff recommends that the Commission issue an Order Recognizing the Name Change, acknowledging the name under which the Company does business as Global Crossing Local Services, Inc., and either approve the revised tariff sheets under tracking number JC-2011-0278 or allow them to go into effect by operation of law.

of Two Separate Corporate Entities

**Date:** December 13, 2010

On November December 1<sup>st</sup>, Global Crossing Local Services, Inc and Global Crossing Telemanagement, Inc. (collectively "Global Crossing") filed a new tariff which reflects an upcoming merger between the companies. Under the proposed merger, local telephone customers of Global Crossing Telemanagement, Inc. are to be merged with and into Global Crossing Local Services. Both entities are currently certificated by the Commission. The new Global Crossings tariff is to be referred to as P.S.C Mo. No. 3, which is to replace Global Crossing Telemanagement, Inc. Tariff No. 1, which is to be cancelled in its entirety effective on December 31, 2010.

Concurrent with the internal merger, Global Crossing has submitted a copy of notice sent to affected customers. The Staff has examined the notice and proposed tariff and finds them acceptable.

The specific Tariff to be approved is Global Crossing Local Services, Inc. PSC Mo. No. 3  
The specific Tariff to be cancelled is Global Telemanagement, Inc PSC. Mo. No. 1

Global Crossing is current in all its Commission annual reports and assessment fees. The Staff is unaware of any other matter that affects, or that would be affected by, this matter.
