- 1. Nexus Communications, Inc. is a certificated interexchange telecommunications company (XA-2004-0214), and competitive local exchange telecommunications company (CA-2004-0204). Nexus Communications, Inc. is also a wireless carrier, designated by the Missouri Public Service Commission as an Eligible Telecommunications Carrier ("ETC") for the purpose of receiving federal universal service fund support for low income customers through Lifeline and LinkUp programs.
- 2. In the attached documentation, Nexus Communications, Inc. demonstrates that it has adopted and may lawfully use the name "Reachout Wireless" for its wireless services in Missouri. As the company may use the d/b/a without using the formal company name, the Staff is of the opinion that formal recognition of the d/b/a should be made in the Commissions records, not only to lessen customer confusion, but to ensure that the company is properly listed in the Commission's reports to the federal Universal Service Administrator, so that it can properly receive reimbursement.

WHEREFORE, the Staff moves that the Commission recognized the name Nexus Communications, Inc. d/b/a Reachout Wireless for Nexus Communication, Inc.'s wireless services in Missouri and instruct its Data Center to update the Commission's records accordingly.
