REPORT AND ORDER

On November 18, 1988, Corrigan Associates Missouri Limited Partnership (Applicant) filed a verified application seeking a certificate of service authority to provide shared tenant services (STS).

The Commission issued its Order And Notice on November 30, 1989, directing its Secretary to send notice of this application. The Commission stated that in the event no proper party filed a request for hearing alleging that the granting of the application is not in the public interest, the Commission would grant the certificate of service authority requested herein on the basis of the verified application. No application to intervene or motion to schedule a hearing was filed.

On September 22, 1989, the Commission's staff filed its Memorandum berein recommending approval of the application.

Findings of Fact

The Missouri Public Service Commission, having considered all of the competent and substantial evidence upon the whole record, makes the following findings of fact.

Applicant requests authority to provide STS within the state of Minsouri.

Applicant is a Missouri Limited Fartnership operating from a principal place of business located at 101 West 11th Street, Kansas City, Missouri 64015.

Attachment B

The Commission set twelve standards for providing ATS in TO-86-53. Staff has reviewed the application in light of these standards and concluded that the instant application meets all of them. Having reviewed the application and its attachments and Staff's recommendation, the Commission finds that a grant of certificate to the Applicant to provide STS at 1828 Walnut, Kansas City, Missouri 64108, would be in the public interest.

Conclusions of Law

The Missouri Public Service Commission has arrived at the following conclusions of law.

Applicant proposes to provide service to the public as a public utility subject to the Commission's jurisdiction pursuant to Chapters 386 and 392, R.S.Ho. (Supp. 1988).

This application is filed persuant to Sections 397.440 and 392.520, R.S.H. (Supp. 1988), which provides that any company offering the resale of local exchange telecommunications service must first obtain a certificate of service authority. Section 392.440 further provides that the Commission shall approve such applicating upon a showing by the applicant and a finding by the Commission, after notice and hearing, that the grant of authority is in the public interest. The requirement of hearing has been fulfilled when all those having a desire to be heard are offered such an opportunity.

The Commission has determined that the approval of this application is to the public interest and a certificate of service authority to provide shared tener services should be granted.

It is, therefore,

ORDERED: 1. That Corrigan Associates Missouri Limited Partnership is hereby granted a certificate of service authority to provide shared tenant service in the state of Missouri. This certificate of service authority is subject to the conditions of certification set forth in Case No. To-86-53.

ORDERED: 2. That this Report And Order shall become effective on the
