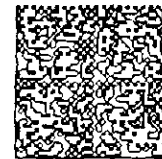

ORDER CANCELING CERTIFICATE

Issue Date: October 2, 2008

Effective Date: October 12, 2008

On September 5, 2008, the Staff of the Commission filed a motion asking the Commission to cancel the certificate of service authority of Greg Elson ("Mr. Elson"), an individual that has been authorized to provide private pay telephone services in Missouri, via customer-owned pay telephone equipment by the Commission.

In Case Number TA-99-407, the Commission granted Mr. Elson a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin telephone equipment.

Staff's motion states that Mr. Elson requested the Commission cancel his certificate of service authority because he is no longer the owner of Robo Wash Laundry and all services connected with the business. The business was sold in September of 2006. Mr. Elson reported zero revenue for 2005 and 2006 and owes no past assessments to the Commission. Staff recommends that the Commission cancel Mr. Elson's certificate of service authority to provide private pay telephone service.


The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and Mr. Elson's request to cancel his certificate, the Commission finds that the certificate of service authority granted to Greg Elson, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide private pay telephone services granted to Greg Elson, in Case Number TA-99-407 is canceled.
2. This order shall become effective on October 12, 2008.
3. This case may be closed on October 13, 2008.
