ORDER DIRECTING FILING

The Commission is directing its staff (“Staff”) to file a memorandum addressing the authorities cited in the filings of Telesphere Networks LTD and iCore Networks, Inc.

Those filings do not show that they are signed by a lawyer authorized to practice in Missouri, so the Commission must not grant any relief based on the filings' content.¹ But it is likely that the Commission must eventually address the issue that the filings raise: whether Congress has pre-empted the Commission's authority over respondents' activities. Staff has suggested alternative relief against respondents on alternative grounds, but has not filed an amended complaint or motion stating whether it still seeks the relief requested in Staff's original pleadings.

Therefore, the Commission will order Staff to file a memorandum addressing the authorities cited in the filings.

THE COMMISSION ORDERS THAT:

1. Staff shall file the memorandum described in the body of this order no later than July 17, 2017.
