On March 24, 2023, the Staff of the Commission (Staff) filed a *Motion to Cancel Registration* regarding the service authority to provide interconnected voice over internet protocol (VoIP) services and to provide basic local exchange and interexchange telecommunications service of Metro Fibernet, LLC d/b/a MetroNet. On April 13, 2023, Staff filed a *Motion to Dismiss*, stating that MetroNet has filed the necessary documentation and worked with Staff to resolve the deficiency causing Staff to open this case.
