## RESPONSE OF LEVEL 3 COMMUNICATIONS, LLC TO ORDER DIRECTING EXPEDITED FILINGS

COMES NOW Level 3 Communications, LLC and submits its response to the Commission's *Order Directing Expedited Filings* in this cause, issued April 4, 2011.

- 1. On March 29, 2011, Level 3 Communications, LLC filed revised tariff pages for its MO P.S.C. Tariff No. 4. They bore an "Issued" date of March 30, 2011, and an "Effective" date of March 31, 2011. A copy of the "Tariff Submission Report" from the Commission's Electronic Filing and Information System (EFIS), showing that the revised tariff pages were actually filed on March 29, 2011, is attached to this Response as "Attachment A." The Commission's Data Center has confirmed to undersigned counsel that these tariff revisions were electronically filed by Level 3, via EFIS, at 10:49:13 a.m. on March 29, 2011.
- 2. On April 1, AT&T Communications and AT&T Missouri filed a *Motion to Reject Tariff* that was assigned File No. TT-2011-0324. A copy of Level 3's tariff filing of March 29, 2011 was attached to the motion as *Attachment 1*.
- 3. The essence of AT&T's Motion is that these revised tariff pages should have been filed with a thirty (30) day effective date under 4 CSR 240-

3.545 (18)<sup>1</sup>, rather than a one (1) day effective date as allowed under 4 CSR 240-3.545 (16) (C) for changes to existing packages of services.

- 4. Without conceding the argument on its merits, Level 3 Communications, LLC has now extended the effective date of these revised tariff sheets from March 31, 2011 until April 29, 2011, or a total of 30 days from the "Issued" date. This renders moot the argument that a 30-day effective date was required.
  - 5. As a result, the AT&T Motion to Reject Tariffs should be denied.

WHEREFORE, Level 3 Communications, LLC respectfully requests that the Public Service Commission of Missouri deny the *Motion to Reject Tariff* filed by AT&T Communications and AT&T Missouri on April 1, 2011.
